Relief requested that Judge John P. Callahan Jr be placed on administrative leave, subject to a psychiatric examination, on the grounds that he went against Dr. Menezes medical advise (**Exhibit 3**) by continuing to expose Christopher Stoller to Attorneys Brad Franco and Stephen Bonanno which caused Christopher Stoller to have Ischemic Attacks. For lying on the record, claiming that the **Chief Judge Timothy Evens** is **NOT** his boss see page 15 lines 14-15 Transcript August 14, 2020 **Exhibit 1**. Thirdly Judge John P.Callahan Jr. attempted to exclude Chirstopher Stoller the Plaintiff from the hearings , that Christopher Stoller need **not** be present for court hearings on the grounds that he has a lawyer. Judge John P. Callahan Jr., totally disregarded the Plaintiff's health safety and well fare pursuant to the recommendations of Menezes medical advice (**Exhibit 3**) which lead Christopher Stoller to have a stroke and the record here clearly evidences that Judge John P.
